Hello BAISD students and Bay County residents with special needs and caregivers/guardians,

Disability Services Resource Center (DSRC) is excited to announce that the Summer Special Needs Enrichment Programs (SSNEPs) have a new theme for all four groups and it is "How Do We Do ... LIFE!"

We are completely thrilled to again offer Blooming Meadows (ages 5-12), Greener Pastures (females ages 13-25), and Open Fields (guys ages 13-25). In addition, this is our third year of offering our program expansion, Rolling Hills. It is for participants between the approximate ages of 26-36! So, between all four of the programs, we will be able to assist those ages 5 through 36. How cool is that?! AND, we are kicking off a new permanent logo (top right) for SSNEPs which is quite colorful and incorporates all four of our programs.

The 2025 programs will be held June 16th - July 23rd at Bangor North Preschool building on Mondays, Tuesdays, and Wednesdays from 10 a.m. – 3:20 p.m. More details are on the enclosed Pre-Admission Forms for each program. Yes, we have included one Pre-Admission Form for each program as, you may, have someone else to pass the additional forms along to for consideration of their participation! As we don't have everyone's birthdate, we will need you to review the enclosed forms and help determine if/where you/your loved one fits age and ability-wise. (Just an FYI, DSRC is now a licensed childcare for our under 13-year-olds)!

PLEASE NOTE: the Pre-Admission Form needs to be completed and returned NO LATER THAN May 30, 2025, directly to DSRC (sooner is always better)! Once a review is completed by our SSNEPs Program Director, Diane Rapson Gabil, for verification of your loved-one's needs and proper placement in the correct program, we will reach back out to you via email with a Registration Form, Medical/Health Form, Media Release Form, the SSNEPs Code of Conduct/Rules, etc. All of these forms must be completed and returned to DSRC with payment by June 9th; yes, BEFORE attending the program.

Payments for DSRC's SSNEPs must be made directly to DSRC after you've received approval of participation and be paid in full before participating in the 2025 program. Payment plans can be arranged directly through me at DSRC.
